UNCONDITIONAL, PERSONAL AND CONTINUING PERSONAL GUARANTY

-Read Carefully-

1. For value received and in consideration of the loans, advances, extensions of credit or other financial accommodations heretofore and hereafter at any time made or afforded by Washington Wholesale Liquor Co. LLC., dba Breakthru Beverage Washington, D.C. (hereinafter referred to as seller) and for the purpose of enabling the Buyer (as identified below) to obtain and/or continue to obtain credit from the Seller, the Buyer and the undersigned (hereinafter referred to as Guarantors_ personally, jointly, severally, and unconditionally guarantee absolutely the prompt and complete payment to Seller upon maturity according to the terms of any and all merchandise sold, charges, sales, services rendered and/or any and all indebtedness (hereinafter referred to as sales) pursuant to an application of credit, if applicable, hereinbefore or hereinafter made by Seller to: _____ (name of company)(hereinafter collectively referred to as Buyer) and also guarantee any costs of collection thereof including but not limited to all reasonable attorney fees of thirty three and one third percent, interest charges, bank fees, or collection agency fees.
2. This is a continuing Guaranty and is in effect as you all sales made by the Seller to the Buyer prior to receipt by the Seller of either written notice from the Guarantors of termination of this Guaranty or written notice of death of the Guarantors. Said written notices must be sent by certified or registered mail to Washington Wholesale Liquor Co. LLC., dba Breakthru Beverage Washington D.C. 2800 V St. NE, Unit E, Washington, D.C., 20018. The death, insolvency and/or bankruptcy of Buyer will have no effect on this Guaranty.
3. Guarantors waive any and all Guaranty defenses, including but not limited to exoneration, all subrogation rights, any changes or assignments in the obligation and/or security by Seller, the benefit of any applicable statute of limitations, all notices of sale, notice of default, presentation for payment, notice of non-payment, protest and notice of acceptance of this Guaranty. Extensions, renewals, indulgences, delays, transfers, transfer to creditors' committees or trustees, settlements and compromises may be in the Sellers's sole discretion, with or without notice to the Guarantors, and will not relieve the Guarantors of any liability there under.
4. Guarantors and Buyer irrevocably submit to the jurisdiction and venue of the local or federal courts in the District of Columbia and, at Seller's option, in the state or federal courts of any jurisdiction where they reside or do business for any action or proceeding against them. Guarantors and Buyer irrevocably authorizes any attorney designated by the Seller, to appear in any court of competent jurisdiction and confess judgment against them for any amount due, plus interest, costs and attorney's fees as allowed herein. Further, Guarantors and Buyer hereby nominate, constitute an appoint Risa Hirao as their attorney-in-fact with authority to confess judgment against them for the unpaid balance due and owing, and interest, costs and attorney's fees allowed herein in the office of the Clerks of the Circuit Courts of Loudoun County, Fairfax County, Arlington County, City of Alexandria, and Prince William County, all in the Commonwealth of Virginia. Should the authorization for confession of judgment be deemed invalid, the remaining provisions of this instrument shall remain in full force and effect.

THIS INSTRUMENT CONTAINS A CONFESSION OF JUDGMENT PROVISION WHICH CONSTITUTES A WAIVER OF IMPORTANT RIGHTS YOU MAY HAVE AS A DEBTOR AND ALLOWS THE CREDITOR TO OBTAIN A JUDGMENT AGAINST YOU WITHOUT ANY FURTHER NOTICE.

5. If any provisions of this Guaranty contravenes or is held invalid under the laws of any jurisdiction, this Guaranty shall be construed as though it did not contain that provision, and rights and liabilities of the parties to this agreement shall be construed an enforced accordingly.
6. There are no conditions or limitations to this Guaranty except as may be agreed upon by the Seller and the Guarantors in writing. I hereby authorize Washington Wholesale Liquor Co., LLC. dba Breakthru Beverage Washington, D.C. to obtain my personal credit information as part of their credit investigation. Guarantors and Buyer agree any oral representations and agreements are superseded and all terms and conditions of the sales and guaranty are contained in this instrument, any other written agreements, instruments, credit applications, and invoices for product sold.
